शाह ने असम में 1,715 करोड़ की विकास परियोजनाओं का लोकार्पण किया

गुवाहाटी, (भाषा)। केंद्रीय गृह मंत्री अमित शाह ने असम के डिब्रूगढ़ में दूसरे विधानसभा परिसर समेत 1,715 करोड़ रुपये की परियोजनाओं का शुक्रवार को लोकार्पण किया।

शाह ने मुख्यमंत्री हिमंत विश्व शर्मा, केंद्रीय मंत्री सर्वानंद सोनोवाल, ऊपरी असम के विधानसभा क्षेत्रों के सांसदों एवं विधायकों, राज्य मंत्रिमंडल के कई मंत्रियों तथा वरिष्ठ सरकारी अधिकारियों की मौजूदगी में इन परियोजनाओं का लोकार्पण किया। उन्होंने डिब्रूगढ़ को दूसरे प्रशासनिक केंद्र के रूप में स्थापित करने के सरकारी के प्रयासों के तहत 284 करोड़ रुपये की लागत से बनाए जाने वाले दूसरे विधानसभा परिसर और विधायक हॉस्टल की आधारशिला रखी। इस परियोजना के तहत तीन मंजिला विधानसभा भवन, विधायकों के लिए नौ मंजिला हॉस्टल, 800 सीट की क्षमता वाला सभागार और सुरक्षा कर्मियों के लिए एक बैंक का निर्माण किया जाएगा। शाह ने 238 करोड़ रुपये से बने आधुनिक खेल परिसर के पहले चरण का उद्घाटन किया और इसके दूसरे चरण की आधारशिला रखी जिसका 209 करोड़ रुपये की



डिब्रूगढ़ में दूसरे विधानसभा परिसर परियोजनाओं का लोकार्पण करने के बाद कार्यक्रम को संबोधित करते हुए केंद्रीय गृह मंत्री अमित शाह। (एएनआई)

अनुमानित लागत से निर्माण किया जाएगा। परियोजना के पहले चरण में इनद्वारा स्ट्रीटिंग, क्विनिंग पूल, फुटबॉल मैदान, मुख्य दर्शाक टीथिंग, टैनिंग, बॉलीबॉल और बास्केटबॉल कोर्ट तथा हॉस्टल शामिल है। अधिकारियों ने बताया कि खेल सुविधा के दूसरे चरण में 30,000 लोगों के लिए बैठने की अतिरिक्त जगह, एक केंद्रीय खेल मैदान और एक एथलेटिक ट्रैक

एफटीए से असम की चाय बिना शुल्क यूरोपीय देशों तक पहुंचेगी

डिब्रूगढ़, (भाषा)। केंद्रीय गृह मंत्री अमित शाह ने शुक्रवार को कहा कि यूरोपीय संघ-भारत मुक्त व्यापार समझौता से सुनिश्चित होगा कि असम चाय को खेप बिना किसी शुल्क यूरोपीय देशों तक पहुंचे। शाह ने डिब्रूगढ़ के खानिकर पंडे ग्राउंड में एक जनसभा को संबोधित करते हुए कहा कि प्रधानमंत्री नरेंद्र मोदी ने हाल में हुए व्यापार समझौते के जरिये असम की चाय की परिसर और बर्लिन के साथ-साथ यूरोपीय संघ के अन्य देशों तक पहुंच सुनिश्चित की है। उन्होंने कहा, यूरोपीय संघ-भारत व्यापार समझौता यूरोपीय देशों को असम की चाय के निर्यात को और बढ़ावा देगा। भारत और यूरोपीय संघ ने मंगलवार को ऐतिहासिक मुक्त व्यापार समझौते (एफटीए) पर हस्ताक्षर किए। इसे अबतक तक सबसे बड़ा व्यापार समझौता कहा जा रहा है। ईयू-भारत एफटीए का उद्देश्य दो अरब लोगों का बाजार तैयार करना है। प्रधानमंत्री नरेंद्र मोदी और यूरोपीय संघ के शीर्ष नेतृत्व ने नियम-आधारित विश्व व्यवस्था की रक्षा के लिए व्यापार और रक्षा का लाभ उठाने के लिए एक परिवर्तनकारी एजेंडा का अनावरण किया। केंद्रीय मंत्री ने चाय बागान श्रमिकों को असम और भारत को दुनिया में चाय के अग्रणी निर्यातकों में से एक के रूप में एक विशिष्ट पहचान देने के लिए धन्यवाद दिया।

हालांकि गृह मंत्री ने जंगली जानवरों के उपचार के लिए 292 करोड़ रुपये को लागत से बनाए जाने वाले वन्यजीव स्वास्थ्य एवं अनुसंधान केंद्र की आधारशिला रखी जिसमें उन्नत प्रयोगशाला सुविधाएं और प्रशिक्षण इकाइयां भी होंगी। अधिकारियों ने बताया कि इससे वन अधिकारियों, पशु चिकित्सकों और शोधकर्ताओं के बीच समन्वय बेहतर करने में मदद मिलेगी।

परियोजना के तहत एक शैक्षणिक और प्रशासनिक ब्लॉक, एक केंद्रीय प्रयोगशाला, एक संग्रहालय, एक अत्याधुनिक सभागार, एक क्लीनिकल ब्लॉक और विकिरण सुविधाओं वाली एक प्रयोगशाला बनाई जाएगी। शाह ने राष्ट्रीय आपदा न्यूनीकरण कोष के तहत आर्द्रभूमियों के जीर्णोद्धार एवं पुनरुद्धार के लिए 692 करोड़ रुपये की परियोजना भी शुरू की।

निजाम के गहने आरबीआई के पास सुरक्षित हैं: सरकार

नई दिल्ली, (भाषा)। निजाम के गहनों का एक सेट भारतीय रिजर्व बैंक (आरबीआई) की उच्च-सुरक्षा में रखा गया है और संस्कृति मंत्रालय इन गहनों के ऐतिहासिक, सांस्कृतिक एवं विरासत संबंधी महत्व से अवगत है। सरकार ने राज्यसभा को यह जानकारी दी।

केंद्रीय संस्कृति मंत्री गजेंद्र सिंह शोखावत ने एक प्रश्न के लिखित उत्तर में बृहस्पतिवार को यह भी कहा कि हैदराबाद में स्थायी सार्वजनिक प्रदर्शनी के लिए इस संग्रह को स्थानांतरित करने का कोई निर्णय नहीं लिया गया है। पूर्ववर्ती हैदराबाद रियासत पर

निजामों का शासन था। स्वतंत्रता के बाद इस क्षेत्र का भारत संघ में विलय कर दिया गया। शोखावत से पूछा गया था कि क्या सरकार को इस बात की जानकारी है कि निजाम के 173 गहने 1995 से आरबीआई की तिजोरियों में सुरक्षित हैं, जिस पर उन्होंने कहा, जी, महोदय। मंत्री से यह भी पूछा गया कि क्या सरकार लोगों के लिए निजाम के गहनों के गहरे सांस्कृतिक, ऐतिहासिक एवं भावनात्मक महत्व, हैदराबाद को विरासत और इस लंबे समय से चली आ रही जनभावना को स्वीकारती है कि इन गहनों के पास उच्च-सुरक्षा में रखे गए हैं।

मंत्रा चिहाए। उनसे यह भी पूछा गया था कि क्या सरकार स्थायी सार्वजनिक प्रदर्शनी के लिए इस संग्रह को स्थानांतरित करने का फिलहाल कोई निर्णय नहीं लिया गया है।

नई दिल्ली, (भाषा)। कांग्रेस अध्यक्ष मल्लिकार्जुन खरगे ने आर्थिक समीक्षा में सूचना का अधिकार (आरटीआई) अधिनियम का फिर से अध्वन्य करने की पैरवी किए जाने का हवाला देते हुए शुक्रवार को कहा कि क्या सरकार मरगेवा के बाद अब इस कानून को खत्म करना चाहती है? संसद में बृहस्पतिवार को प्रस्तुत वव 2025-26 की आर्थिक समीक्षा में लगभग दो दशक पुराने आरटीआई कानून का फिर से अध्वन्य करने की वकालत की गई है, ताकि गोपनीय रिपोर्ट और मसौदों को सार्वजनिक

किए जाने से छूट प्राप्त हो। आर्थिक समीक्षा में यह भी कहा गया कि आरटीआई अधिनियम 2005 का मकसद कभी भी इसे व्यर्थ की जिज्ञासा का जरिया बनाने का नहीं था, न ही इसका मकसद बाहर से बैकडर सरकार के हर छोटे-छोटे काम में दखल देना या उसे नियंत्रित करना था। खरगे ने एक्स प्र पोस्ट किया, आर्थिक समीक्षा में सूचना का अधिकार अधिनियम की फिर से अध्वन्य करने की पैरवी की है।
