

नीतीश के खिलाफ भ्रष्टाचार का कोई मामला नहीं : राजनाथ

वैशाली, (भाषा)। रक्षा मंत्री राजनाथ सिंह ने मंगलवार को बिहार के मुख्यमंत्री नीतीश कुमार की तारीफ करते हुए कहा कि उनके नेतृत्व में प्रदेश में सुशासन कायम हुआ है और इतने वर्षों तक सत्ता में रहने के बावजूद उनके खिलाफ भ्रष्टाचार का एक भी मामला नहीं है। उन्होंने यह भी कहा कि राष्ट्रीय जनतांत्रिक गठबंधन (राजग) सरकार ने बिहार के सर्वांगीण विकास के लिए अभूतपूर्व कार्य किए हैं। बिहार के वैशाली में चुनावी सभा को संबोधित करते हुए सिंह ने लोगों से राजग के पक्ष में मतदान की अपील की।

भाजपा के वरिष्ठ नेता का कहना था, बिहार को आगे बढ़ाने की सोच सिर्फ राजग ही रख सकता है। हमें मिलकर विकसित बिहार बनाना है। उन्होंने कहा कि वर्ष 2014 से पहले भारत को अर्थव्यवस्था विश्व में 11वें स्थान पर थी, लेकिन प्रधानमंत्री नरेंद्र मोदी को नेतृत्व में देश अब पांचवें स्थान पर पहुंच गया

हैं और जल्द तीसरे स्थान पर पहुंच जाएगा। रक्षा मंत्री ने केंद्र की पूर्ववर्ती संयुक्त प्रगतिशील गठबंधन (संप्रग) सरकार को निशाना साधते हुए कहा कि संप्रग शासन के दौरान केंद्र सरकार ने बिहार को मात्र दो लाख करोड़ रुपये दिए थे, जबकि मोदी जी की

सरकार ने पिछले 10 वर्षों में पंद्रह लाख करोड़ रुपये जारी किए हैं। उन्होंने कहा कि राजग ने बिहार को नई ऊंचाइयों पर पहुंचाने का काम किया है। राजनाथ सिंह ने विपक्षी इंडियन नेशनल डेवलपमेंटल इंक्लूसिव अलायंस (इंडिया) गठबंधन पर हमला बोलते हुए कहा, वे हर परिवार के एक सदस्य को सरकारी नौकरी देने का वादा कर रहे हैं, लेकिन यह नहीं बता पा रहे कि इसके लिए धन कहाँ से आएगा। उन्होंने कहा कि इंडिया गठबंधन के नेता जनता से झूठ न बोलें, उन्हें सच बोलना चाहिए। सभा के अंत में उन्होंने लोगों से कहा कि राज्य में एक बार फिर राजग की सरकार बनेगी तो बिहार विकास की नई राह पर अग्रसर होगा। जंगलरज नहीं, सुशासन और प्रगति का युग जारी रहेगा।

नीतीश को भाजपा ने पकड़ रखा है, अब कभी नहीं बनेगी उनकी सरकार: राहुल

औरंगाबाद (बिहार), (भाषा)। कांग्रेस के पूर्व अध्यक्ष राहुल गांधी ने मंगलवार को दावा किया कि बिहार के मुख्यमंत्री नीतीश कुमार को भारतीय जनता पार्टी (भाजपा) ने पकड़ रखा है और अब इस प्रदेश में नीतीश कुमार की सरकार कभी नहीं बनने वाली है।

उन्होंने औरंगाबाद और कुटुंबा में चुनावी सभाओं को संबोधित करते हुए यह भी कहा कि जिस तरह रिमोट के जरिये टेलीविजन चैनल बदले जाते हैं, उसी तरह प्रधानमंत्री नरेंद्र मोदी और गृह मंत्री अमित शाह नीतीश कुमार का चैनल बदलते हैं तथा बिहार के मुख्यमंत्री वही करते हैं जो भाजपा के ये दोनों शीर्ष नेता चाहते हैं। लोकसभा में नेता प्रतिपक्ष ने दावा किया कि प्रधानमंत्री मोदी और गृह मंत्री वोट चोरी की पूरी कोशिश करेंगे क्योंकि उन्हें पता है कि इसके बगैर वो जीत नहीं सकते। राहुल गांधी ने लोगों का आह्वान किया

कि वह वोट चोरी को रोकने के लिए मुस्तैद रहें। कांग्रेस नेता ने एक बार फिर यह दावा किया कि नीतीश कुमार, प्रधानमंत्री मोदी और गृह मंत्री शाह के इशारे पर काम कर रहे हैं। उनका कहना था, बिहार के लोगों को लगता है कि नीतीश जी की सरकार है। लेकिन नीतीश जी का कोई लेनादेना नहीं है। जैसे रिमोट से टीवी का चैनल बदला जाता है, वैसे ही मोदी जी और अमित शाह, नीतीश जी का चैनल बदलते हैं। वह जो चाहते हैं, उसी रिमोट की वही करते हैं। राहुल गांधी ने दावा किया, भाजपा ने नीतीश जी को पूरा कंट्रोल कर रखा है, दबाकर पकड़ रखा है। बिहार में नीतीश जी की सरकार कभी नहीं बनने वाली है। खत्म हो गया काम...। कांग्रेस नेता ने बिहार

की शिक्षा व्यवस्था की स्थिति का उल्लेख करते हुए कहा कि कभी ऐसा समय था जब चीन, जापान और अन्य देशों के छात्र पढ़ाई के लिए बिहार आया करते थे, लेकिन आज बिहार के युवाओं को रोजगार के बजाय पलायन के लिए मजबूर होना पड़ रहा है। उन्होंने घोषणा की कि इंडिया गठबंधन की सरकार बनने पर नालंदा में विश्व स्तर का विश्वविद्यालय स्थापित किया जाएगा। प्रधानमंत्री मोदी पर निशाना साधते हुए राहुल गांधी ने कहा, मोदी जी कहते हैं कि युवा रील्स बनाकर पैसा कमा रहे हैं। रील्स कमा रहा है? उस पैसा से फायदा अदागी और अंबेसा को हो रहा है। कांग्रेस नेता ने यह भी कहा कि प्रधानमंत्री युवाओं को व्यस्त

रखना चाहते हैं ताकि वे सवाल न पूछ सकें। उन्होंने कहा कि मोदी जी युवाओं को उसी तरह एक नए नशे में लगा रहे हैं, जैसे शराब या ड्रग्स का नशा होता है। कांग्रेस नेता ने बिहार के स्वास्थ्य ढांचे पर सवाल उठाते हुए कहा कि बिहार से जो लोग इलाज के लिए दिल्ली एम्स जाते हैं, वे कहते हैं कि अगर बिहार के अस्पतालों में भर्ती हुए तो जान चली जाएगी।

सेना में भर्ती से संबंधित अग्निपथ योजना को लेकर राहुल गांधी ने दावा किया, इस योजना में न तो युवाओं को पेशान मिलेगी और न ही शहीद होने पर मुआवजा या अनुग्रह राशि। उन्होंने कहा कि बिहार में प्रश्न पत्र लीक होते हैं और अमीर छात्रों को उसका लाभ मिलता है, जबकि गरीब छात्र मेहनत के बावजूद पीछे रह जाते हैं। प्रधानमंत्री मोदी पर कटाक्ष करते हुए राहुल ने कहा, नरेंद्र मोदी छोट पूजा के समय यमुना में स्नान करने वाले थे।
